RULES FOR WINTER.

I. Keep no more stock than you can keep really well. If you have more, rack to the most inferior and sell them. Better to winter a few head well than a large number in a poor condition...

II. Heat and shelter are equivalent to food. Ask yourself whether it is better to winter a few head in a good shed, which will last for years; or half your fodder; and preserve your stock healthy and comfortably...

III. You cannot make your young animals too comfortable, or feed them too well. Under a good shed, and in a good stall, or starved, they will never recover. It applies to all kind of stock, but especially to calves and colts...

IV. Therefore make provisions not only for the winter, but for the spring. Hay should not be fed for them. If you have no roots, feed on grass, and crushed oats and corn...

V. If this has been fully proved, if your sheep are shut up all winter with a sufficient quantity of water, they will be able to endure the winter and make a satisfactory spring pasture...
