The M. C. Railway Case. Raleigh, N. C., July 27.—The threatened conflict between the State of North Carolina and the Federal government over the enforcement of the new 2-1-cent passenger rate adopted by the legislature has been averted by an agreement reached at a conference late today between Gov. Glenn and the council of State and the railroad companies of the Southern Railway and the Atlantic Coast Line railroad.

The representatives of the railroads met in general session to not the new rate into effect on Aug. 8, the roads taking this time to prepare their tariffs and make changes. The subject of the new rate is being discussed in an orderly way into the courts, and pending cases and judgments. The agreement reached is practically the same proposed by Gov. Glenn of his telegram to Solicitor Mark Brown at Asheville several days ago.

The railroad puts the 2-1-cent rate into effect not later than Aug. 1. The State to appeal from the order of Judge Pritchard describing parties in Asheville on writ of habeas corpus and to direct against it.
