PLEASE NOT TO ENTER RACE FOR GOVERNOR

Quoted in Correspondence From Columbia—Peoples and Stuckey to Run.

In the Columbia correspondence of the Charleston American yesterday, C. L. Blaise was quoted as saying that he would positively not be a candidate for governor in 1918. It was noted that he would not be a candidate for another office.

Attorney General Peoples was, in the same correspondence, quoted as announcing positively his candidacy for governor, biennial session, of the general assembly and the recall of State officials (to be provided by constitutional amendment) near his platform.

W. A. Stuckey of Lee County, "practically placed himself in the field for governor on a platform of economic issues," saying that "his own intention now is to be a candidate for governor."

Railroad Commissioner John C. Richards said that "he was at the command of the Reform Party, that he would consider it an honor to be selected by them as their candidate for governor or to take any other position in the ranks to which the Reform Party might assign him."

"Personally I have no objection to make. If the members of the party desire, after careful consideration, conclude that it is their desire for me to become their candidate for governor, I shall abide by their wishes and go into the race with all my power and strength."
