STRIKE ORDERED ON NEW YORK'S ELECTRIC ROADS

Subway Elevated and Surface Lines Affected—Transportation Facilities May Be Tied Up Completely by This Morning

New York, Sept. 6.—A strike was declared early tonight by unionized employees of the subway and elevated railway lines operated by the Interborough Rapid Transit Company...

Union officials asserted that with the possible exception of the lines in Brooklyn, New York's electrical transportation facilities would be completely paralyzed tomorrow...

**WORK BOTH WAYS  
TO SECURE VOTE**

**Efforts to Gain Franchise Through  
Action by Ethical Course  
Recommended.**

Atlantic City, N. J., Sept. 6.—The National American Woman Suffrage association by an overwhelming vote today decided to continue its present policy of working for equal rights through both national and State legislation. The vote was taken after a long debate and no sooner had the speakers finished than the announcement ceased than a resolution was presented which threatens to again open the whole question tomorrow.

"Virtually all the speakers declared for strict neutrality in the presidential campaign, and to continue the non-partisan efforts of the association to bring about equal suffrage throughout the nation by State action from every State are attending the 48th annual convention of the association, which was called two months in advance of its regular meeting because of the national political campaign.

The question of continuing the present policy of the association came before the convention in the form of two resolutions. The first, the organization's constitution concentrate on the proposed amendment to the federal constitution by a viva voce vote.

Then Mrs. Carrie Chapman Catt, president of the association, presented the following resolution:

"That the 48th annual convention of the National American woman Suffrage association interpret article 2 of the constitution, which pledges our auxiliaries to secure the vote for women by appropriate national and State action as meaning that the federal amendment is our immediate and principal aim; and that all State campaigns, whether legislative or reform, are preparatory to this end."

Miss Laura Clay of Lexington, Ky., a staunch advocate of State rights, attacked the resolution as undemocratic and as nullifying the action just taken by the convention. The resolution also stirred up opposition among other delegates and there was every evidence of a stormy session. A motion by Miss Clay that the resolution be laid on the table was defeated and the further debate was shut off by the carrying of a motion that the resolution be made a special order for 11 a. m. tomorrow.

Mrs. Catt and other leaders anticipate a lively debate, but expressed confidence that the resolution would be adopted.

There was a three cornered debate on the policy question. Miss Clay led the forces who favored exclusive State aim; Mrs. Ida Husted Harper of New York was the principal speaker for concentration on the federal amendment, and Mrs. Raymond Brown, New York, made the principal address in favor of no change in policy.

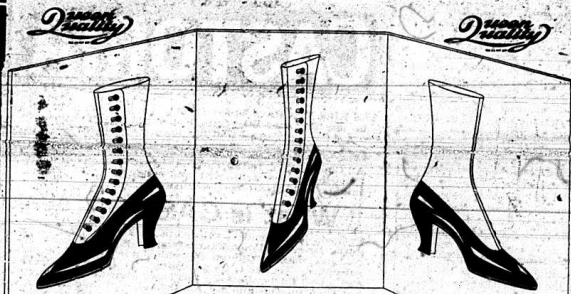

**NEGRO SHOT AND INSTANTLY KILLED BY WELL-KNOWN CHESTER FARMER**

Last Tuesday afternoon Green Blake, colored, was shot and killed by Mr. J. M. Sanders, of the Roseville section of Chester county. The shooting affray took place in Hazwood township some four or five miles from Blackstock.

When information obtainable it appears that Mr. Sanders' cattle got on the crop of Blake, who rents from Mr. Sanders. Mr. Sanders offered to pay Blake for the damage done by the cattle but the negro would not accept the offer and used some very heated words during the course of the conversation, even threatening the life of Mr. Sanders, so we are informed Mr. Sanders was not armed at the time and left negro.

After the conversation the negro left and went to see Magistrate R. R. Stiebel about the matter. The magistrate told Blake to remove the cattle by arbitration, or words to that effect. The negro then left and several miles out from Blackstock he met Mr. Sanders, who was enroute to see the magistrate in a buggy.

It is stated the conversation was renewed and ended in Mr. Sanders shooting and fatally wounding Blake. There were no eye-witnesses to the shooting but it is stated that he heard three shots and saw the third one fired by a white man but did not know the man.

Mr. Sanders notified Sheriff Collins and to the home of Mr. Sanders and brought him to Chester. The shots were fired at such close range that the clothing of Blake was set on fire and burned off with the exception of a little below the knees.

Coroner Gladden held the inquest Tuesday night, the following being jurymen: W. S. Dickey, Foreman; E. W. Mobley, E. M. Giffin, W. H. James, T. E. Minton and B. M. Bagley. The verdict of the coroner's jury was that Green Blake came to his death from the effects of pistol shot wounds fired by J. M. Sanders.

The particulars as to the conversation etc., which took place when the two met in the night has not been made known but it was learned that Mr. Sanders' shirt was practically torn off of him.

**Second Primary Election Tuesday**

The election tickets and boxes are now ready for delivery to the various managers of the county.
