**America in Aeronautics.**  
Paris, Oct. 2.—The United States herself is a quantity to be reckoned within aeronautics. This is the verdict following the victory of Lieut. Frank P. Lahm in the balloon race for the Gordon Bennett cup. Although there is talk that owing to Lahm's great showing the next balloon race should be held in America. Previous to the race Lahm, American, was not regarded as cutting much figure in the contest. This wonderful feat of piloting his balloon 400 miles in twenty-five hours is the talk of Paris.

The greatest surprise is expressed that an American should have accomplished so much as Europe always has been inclined to regard the United States as a negligible quantity in aeronautics.

**LAHM DESCRIBES HIS JOURNEY.**  
London, Oct. 2.—Lieut. Frank P. Lahm, of the Sixth cavalry, United States army, winner of the international balloon race, arrived in London today from Whitby, where he spent the night. The Houstonian and Maj. Henry, his companion during the trip, described their voyage as having been most delightful, the weather favoring them from the start until shortly before the finish, when an easterly wind sprang up and took their balloon, the United States, dangerously close to the cliffs near Whitby.

At the start, Lieut. Lahm said, his wearily waded the balloon over Western France, and then, veering northwestward, took her across the channel south from just north of Cher to the eastward of Chichester. They had a beautiful moonlight trip for crossing the channel and greatly enjoyed the experience. The balloon was so low and maintained her equilibrium so well that the aeronauts were enabled to see persons on the decks of the channel steamers.

After crossing the channel the wind took the United States almost directly north, along the coast and had the breeze continued favorable, Lieut. Lahm said, she would have been in Scotland in reaching Scotland. As it was an easterly wind sprang up and was carrying the balloon back seaward to the aeronauts made a leisurely one, ascending "not far from the railroad station."

**In the House of Their Friends.**

ATriple of Tragedies Among Negroes. Last Friday, Coroner Leckie was called to Loudan to hold an inquest on the body of a colored woman, Mrs. Wm. Jordan's place. The facts brought out were briefly, that two boys were fooling with a porcupine, trying to put a candle in its tail. The porcupine slipped, and the boy, the hammer slipped, and the gun was discharged, killing the child, who was standing in range nearby. The boys were charged with the original carelessness and committed to jail.

While the coroner was engaged on this case a messenger came and notified him that another case awaited him on Mr. Thompkins's place. There also a child had been killed. Saturday night, Jessie Moore, who had been employed for years as a nurse in Dr. S. E. McFadden's family was shot by John Henry Moore in her room on Mr. Miller's place, which she shared with her "adopted aunt." This aunt said that Jessie ran to her bed and waked her saying that John had shot her. She said she saw John go out and go out. He went by Dr. Miller's and gave the information that Jessie had been shot. He then went to Dr. E. B. Cornell's and reported having with some one while attempting to shoot a man in self-defense. After Mr. Cornell turned something of the facts he brought him to jail. The girl lived some four hours and made a statement, which was not signed. It seems that Moore had been making love to her but she was to be married the next day to another man. She visited her Saturday night, and when his advances were resisted he shot her, in a fit of jealousy. It is supposed that Coroner J. P. after hearing the testimony at hand, including Moore's statement to Mr. Cornell, found that the deceased came to her death from a gun shot, wound at the hands of some one unknown. Coroner Leckie declined to sign this verdict and after consulting Solicitor Henry swore out a warrant, which was served upon Moore in the jail.

When this Jessie Moore was an infant, she was brought to Blackstock by her mother, a stranger, who asked Susan Moore to keep her baby, and she went to Chester and returned. She never returned, however, and Susan and her husband, Jim Moore, highly respected colored men, raised the child, with some assistance from the white people. John Henry Moore, who killed Jessie, and Mary Moore, with whom she lived, are grand children of Jim and Susan.
