### State Income Tax Methods.

The Charleston News & Courier says:

"The South Carolina at the present time some of our most important industries are on the point of leaving the State and locating elsewhere. The terms of the State income tax in this State and the manner of the enforcement of this tax are driving them to other and friendlier Commonwealths."

"This is not bluff. It is the absolute fact. These concerns are required to pay an income tax in this State on income from plants which they conduct in other States. They feel that it would pay them to make their headquarters in the States where their other plants are and conduct their operations in South Carolina as branches of their main business, if at all."

"There is resentment, too, at the needless toll of time and effort which they are called upon to pay under the State income tax system. What they cannot understand, at The News and Courier has pointed out repeatedly, is why one income tax return could not be made to do for both the Federal and State governments. As a matter of fact, a simple affidavit in the State treasurer could be made to cover the whole business, setting forth the amount of the taxes paid the Federal government, and forwarding remittance for its amount based on the Federal taxes. This affidavit should also show, as one business man who has been compelled to give an outline amount of study to the question says, what taxes were paid during the current year for back taxes since 1921, assessed by the Government, and also any refunds made by the Federal government for the same period. As a check against this affidavit, suggests our correspondent, the income tax returns are now open

### EDITOR GRIET IS STRICKEN AT YORK

Veteran Newspaper Man a Victim  
of Apoplexy

Wood Davidson Griet, for 35  
years editor of the Yorkville Ex-  
aminer, died suddenly at his  
home at York at 7:30 p. m. Tues-  
day morning after complaining  
just getting ready to go to the  
city hall to preside over a public  
meeting he was seized with a  
choking spell. He was carried  
to bed and expired shortly after his  
physician arrived.

Funeral services were held  
from the Yorkville Associate Re-  
formed Presbyterian church, of  
which he was a ruling elder, yes-  
terday morning at 11 o'clock, con-  
ducted by his pastor, the Rev.  
Nat. K. Smith.

Mr. Griet was born in York, No-  
vember 12, 1865; the son of John  
and Lewis Mason Griet and  
Frances Vioe Griet. He was ed-  
ucated at King's Mountain Pres-  
byterian academy, Col. Asbury  
College and after completing his  
education went to work in the  
office of the Yorkville Examiner.

Later he went to Atlanta and  
worked on the Atlanta Constitu-  
tion with Henry W. Grady, John  
Chandler Harris, Frank L. Stan-  
ton and others.

January 1, 1899, he became ed-  
itor of the Yorkville Examiner and  
remained at that post until his  
death. He never sought public  
office and declined numerous  
honors, always taking the posi-  
tion that it was not in keeping  
with the life and work of a  
newspaperman.

He was married in 1904 to Miss  
Edith Tall, of that city. She  
took place in York county, The  
school at Leeds has been closed  
since last Monday due to the fact  
that both parties above mentioned  
were the only teachers in the  
school.

### SHOOTING COMMENT.

Editorial comment of the Ches-

of last week, in which Dewey  
Simpson met his death, is a rather  
far expression if it is the state-  
ments made can be declared sane  
and acceptable.

If Officer McFadden could have  
secured the names of the parties  
in the automobile he might have  
secured later warrants and ar-  
rested the party at that time.

But there is one other phase  
of the situation that the News  
editor dwells on at considerable  
length. That is the competency  
of our officials and the need to  
pay liberal salaries so as to secure  
the very best.

At such a time as this it is  
perfectly easy to talk of paying  
high salaries and secure the most  
efficient officers. It is possible to  
obtain. It is a fine time to state  
that our officers should be put  
through a course of training,  
bringing about the highest effi-  
ciency, and then pay salaries in keep-  
ing with such expert talent. Now  
is the time to talk such efficiency  
for life has been taken, and when  
popular judgment rises a  
against an unfortunate affair it is  
easy to suggest a host of ideas for  
the conduct of official life.

But when county delegations  
meet, when legislatures are in  
session, when city councils con-  
sider appropriations, the great  
work from the masses is for econ-  
omy and lower taxes. Very often  
the wise and sensible thing to do  
is to engage high priced officers  
to include in what appears to be  
extravagance but what is in  
reality good sense.

We believe with the Chester  
News that our officials should be  
the best trained men and should  
be steady of nerve, cool of judg-  
ment, and slow to action in the  
use of weapons. But even the  
best of men step over the bounds  
of reason at times.

We have not heard all the ter-  
rifying in the shooting affray any  
yet and some facts may be pre-

attitude to be taken toward Offi-

Didn't Like a Sack of Judge

The lawyers employed by  
Judge DeVore to defend George  
Durham, after Sam Durham, a ne-  
gro who was under indictment on  
a serious charge, had a hard time

noon that the best thing he could  
do was to plead guilty to another
