## Its tax time!

Are you ready this year? If not, the Internal Revenue Service (IRS) has added several online services to make the process a little less painful.

Did you know that if your adjusted gross income was \$56,000 or less in 2008, you can get help with your tax preparation and file your taxes for free? The Free File program provides free federal income tax preparation and electronic filing through a partnership between the IRS and the Free File Alliance LLC, a group of private sector tax software companies. You can also e-file your taxes through a tax preparer or with your personal computer. For instructions and a list of IRS e-file partners go to the [Electronic Tax Filing Program](#).

### [How Much Was my Stimulus Payment?](#)

### [Online Employer Identification Number \(EIN\)](#)

Receive your EIN within minutes.

### [Alternative Minimum Tax \(AMT\) Assistant](#)

If you are not using software to prepare your Form 1040 return, you can use this tool to determine whether you may be subject to the AMT.

Find out if you are eligible for EITC by answering questions and providing basic income information. You can also estimate the amount of your credit.
