A recent dispatch from Detroit, Michigan, says:

"So many friendly and unknown negroes have died, been taken to the morgue, and falling identification have been buried in the potter's field here that civic authorities, together with negro ministers, are taking steps to provide every immigrant Southern negro with identification card, giving the address of his nearest Southern relatives, or 'white folks.'"

"Seventy five per cent of the unidentified dead in the Detroit morgue are negroes, according to the Detroit News, and the majority of these are newly arrived from the South. Tuberculosis, typhoid, and in some cases actual starvation, are responsible for the majority of the deaths, although a surprisingly large number of killings occur when the negro competes with the low grade immigrant, and race clashes between the negro and the immigrant classes are becoming more and more frequent."

Top soil is being placed along the York-Chester road, on the York side of the line, for the purpose of re-surfacing this important highway. When the York side was constructed it was not properly leveled and it is to be hoped that this time it will be put in proper shape.

SURE TO WIN.

Pittsburgh-Plus is a business practice that has aroused widespread opposition. That there must be some point or points for which the price is paid for every commodity well will dispute. In the case of a world commodity like wheat, Liverpool sets the price. It is fixed by world needs and our exportable wheat is sold at that price. In the case of steel, production is regulated. It is made in a number of large manufacturing centers. With big steel centers at Chicago and elsewhere on the Lakes and at Birmingham, the people of the Middle West and the South cannot see the justice of charging them Pittsburgh price plus freight for steel no matter where produced.

Pittsburgh was selected as the base-price point in the early days because it was then the center of raw materials and manufacture and near the markets. Both population and industry have grown since that time. But none of this movement helps Western farmers and other consumers. They are tired of paying freight from Pittsburgh on steel made in Chicago from iron and fuel mined in their own back yards.

They resent being compelled to pay tribute to Pittsburgh. They resent what they believe is the effort of a few men to defeat the rights of other industries have a number of price-basing points; Western consumers believe steel should be no exception to the rule. So they are determined to abolish Pittsburgh-Plus. The fight now being made before the Federal Trade Commission is merely the opening skirmish. If the people lose they will appeal to the Supreme Court; if they lose, again the case will almost inevitably be thrown into politics. What may happen then no one knows. If the leaders of the steel industry are wise they will reorganizing their arguments before the issue becomes a great one. The history of the railways should be sufficient warning.

Regardless of whatever justice there may be in giving Pittsburgh as the sole basing point, the practice is doctored. This is not a fight waged by a few embittered farmers; it is a fight of all the people of the Mississippi Valley and beyond for what they believe are their rights. There can be no doubt as to the outcome.

It is much better that reform come from within a great industry than that they be forced upon it from without. Those who understand all conditions are in the best position to act. The Country Gentleman believes with Mr. Gray that Pittsburgh-Plus is making its last stand. It believes that right now is the time for the men who control the steel industry to act. It is contending for an industry and for the right to permit economic issues to become the foothold of politics. Country Gentleman.

At the last session of the Legislature, an appropriation was made to match Federal funds for studying weevil control. In addition to the regular experiments being carried on at the Pee Dee Station at Florence and at Clemson College, there are 25 farms in the state that are cooperating with the authorities in studying weevil control.

Mr. Joe Frazer of Chester is cooperating with State and Federal authorities in this work and a man in charge all of the time on the farm studying the situation and conditions. Weevil infestation counts are made every week, the rainfall and temperature are noted, and other factors influencing weevil control are considered.

The land is laid off in two to three acre plots, some will be poisoned throughout with molasses-calcium arsenate mixture, others will be dusted entirely and plots will be kept untreated to act as check plots. Mr. J. G. Lewis is in charge and the molasses poisoning has been done ten days ago. About 15 weevils were found in the 3000 plots last week. It will be interesting that we watch the results of this summer.

Cooperating with the Southern Cotton Oil Co., Messrs. Robert Lindensweig and C. C. McAlley are each running ten acres tests with the dusting method and another ten acres heavily fertilized, undusted and dusted. 4 acres heavily (900 lbs.) fertilized and dusted, one acre lightly fertilized and undusted, one acre heavily fertilized, undusted. These tests have already been dusted the first time.

Mr. L. M. Wootten, Lewis Tarnum is running a ten acre test with the dusting method in cooperation with the American Cotton Association. The experiment is being carried on the land between the highway and railroad where a tremendous crop of bur clover has been turned over for several years, and it is with interest that we watch the development of this test.

**IMAGINING HIMSELF GOD,
FOR MURDERING SEATAN*
S. C. MAN WAS EXECUTED**

The Greenwood Index-Journal recently published the following editorial account of a little known happening in the early history of South Carolina:

"That a man as a result of religious derangement should imagine himself to be God and while under this hallucination killed a fellow man and the demon that the other man was 'the devil' and then be hanged for his crime in Charleston is an item of South Carolina history not known so commonly, as Sergeant Jasper's saving the flag and a few others."

Bishop Francis Asbury in his Journal on the occasion of being near "Weaver's Ferry on Saluda River," related the tragic event as having been told him by inhabitants of that region.

A very small account of it is to be found in German settlements and the Lutheran church in the Carolinas by Dr. G.D. Bernheim.

The man who was hung in Charleston was Jacob Weber also referred to as Jacob Weaver. In a signed confession written in the Charleston jail before he was hanged he signs his name "Jacob Weaver." The confession is dated April 16, 1761. He was hung near Lexington.

Weber lived in what is now Lexington county not far from Saluda River—hence Weaver's or Weber's Ferry. Around him were Scotch and German Paltine settlers. The Paltines, it will be recalled, were Germans who through persecution had fled to London for refuge and became so numerous that King George paid a bounty of 20 shillings per head to transport them to America after having assured them that they would be given lands of their own in the new country. This was done and many thousands came to South Carolina under this plan.

It is a well known fact to all students of theology that religious persecutions inevitably bring religious hallucinations. Witness the case of the Camisards in France. A hundred years of persecution there failed to change these plain people of the hills from Protestantism to Catholicism but it did cause to develop some of the strangest and weirdest hallucinations known to history. Stevenson in his charming notes on his journey through the land of the Camisards notes that in those terrible days of persecution the Protestants were one and all beside their minds with zeal and sorrow. They were all prophets and prophetesses. Children at the breast would exhort their parents to good works. "A child of 15-months at Quissac spoke from its mother's arms agitated and sobbing, distinctly and with a loud voice," Marshall Villars had seen a town where all the women had seemed possessed by the devil and had trembling fits and uttered prophecies upon the streets. "And it was not only women and children. Stalwart, dangerous fellows used to swing the sickle or to wield the forest axe were likewise shaken with strange paroxysms, and spoke ora-

cles with sobbs and streaming tears. This condition in France among the Camisards was but a sample of what was to be found in any land where the people suffered religious persecution.

In South Carolina the poor Paltines were not persecuted but they had been in their native land and having come to this new and strange country, separated by thousands of miles much of the distance being across the ocean itself so wonder their simple minds were distracted.

Jacob Weber was the father of a sect which took his name and continued to spread even after he had been hung through his fellows did not combine his fatal hallucination of believing that any one of them was God. It is said the sect spread from South to North Carolina, then into Maryland and Virginia. Though the history took the name of Weherites Dr. Mühlenberg in his account says that the founder of the sect was one Peter Schmidt. Weber himself was a Silesian. He first became an exhorter—the settlers had a sermon from a visiting clergyman about every twelve weeks. Weber pretended to be God the Father, sinners the Son, and a third the Holy Spirit; and the pretended a Father having quarreled with the Son, repudiated the pretended Son, chased him in the forest, and finally fathered his gang, who all killed; he is reported also to have died; he pretended holy ghost in bed. A report of these circumstances having reached the authorities in Charleston the militia were ordered to arrest the pretended deity, when he was tried, condemned and executed upon the gallows.

Dr. Hanftus tells of how Weaver, a leader persecuted Christ another the Holy Spirit, a certain woman, the wife of Weaver, the Virgin Mary and one poor fellow was doomed to represent Satan. He says excess followed excess until at length Weaver (Weber) representing either Christ or God, ordered in virtue of his dignity, that Satan should be chained in a pole in the ground and finally that he should be destroyed. For this purpose they met, placed the unfortunate man in a bed, covered him with pillows, on which some seated themselves, while until the life of the man became extinct. The corpse was then taken out of bed and thrown into a burnable pile of wood, to be consumed in ashes.

Weaver (Weber) was tried and sentenced to be hung. His wife was pardoned. He was hung some time after April 16, 1761, in Charleston.

It is impossible to realize at this day and time that such a thing could have happened in South Carolina.
