Fowler, a resident of Piedmont, South Carolina, is a deputy state superintendent at the [S.C. State Department of Education](#). She graduated from Winthrop with a Bachelor of Science in special and elementary education, followed by a Master of Education. She went on to receive principal and superintendent certification and a Ph.D. in educational leadership from Clemson University.

Among Fowler's first actions as a Winthrop board member was to take part March 13 in the selection of Dan Mahony as the university's 11th president.

"I am thrilled to be giving back to Winthrop by serving in this capacity. Winthrop equipped me with the foundation I needed to start my career in education, and I will forever be grateful," Fowler said.
