THE MAYOR SHOULD RESIGN.
In view of the circumstances connecting him with the dispensary scandal and which he acknowledged on the stand in Columbia last week we think that Mayor Samuel should at once resign in view of the fact that his friends can give him no help in this matter.

It is not necessary for The Lantern to rebuke the disclosures. They were printed in its issue last Friday besides being in The State and other papers that same day. Chester is being held up with scorn before the eyes of the world today as a result of the testimony of her mayor in Columbia and it is not probable that the good law abiding citizens of this community will stand idly by and make no protest.

Our local contemporary carried a statement yesterday about Mayor Samuel in which it appears that he says that the reports of his confessions on the witness stand in Columbia are exaggerated. That the report of The Lantern on the matter was correct we know and if that is all that we will get a transcript of his testimony and publish it verbatim.

It looks like Chester, people ought to get busy about their present mayor having been mixed up in the dispensary graft affair.—Rock Hill Record.

GOOD ROADS.
We are publishing in this issue several interesting and valuable articles on roads which we trust will be of interest to our people.
Our citizens in mass meeting have recommended the two mill levy and a 5 cent communication tax, but they should not allow interest to lag. Keep the movement alive and let Chester equal to build some of these roads.

DANGEROUS TO THE CITY'S HEALTH.
The slaughter pen which is located just a little beyond the foot of Columbia street, near the railroad, is dangerous to the health of our city and should be moved. It is situated on a narrow strip of land, the rear of several residences on Columbia street and which carries all the refuse from this old slaughter pen right by the back door of these residences. As a breeder for disease, it has no equal and is positively a menace to the health of the residents of that section.

The slaughter pen which is located outside the city. The board of health should take this matter up and they have the power to have it removed when it is known that it is dangerous to the residents near it are danger. Not only that, but sanitary conditions around the slaughter pen need looking into, and if the board of health refuses to take it up then city council should see to its being removed. That part of the city fairly rears with stenches as a result, and they are not only carriers of disease, but make life miserable to the people near them. We earnestly recommend that the board of health look into this matter and act on it and have this slaughter pen removed.

THE KINGS MOUNTAIN MONUMENT.
On Oct. 7th there will be dedicated on the Kings Mountain battle field a monument to the heroes of the American army who fell there on the occasion of the battle of Kings Mountain Oct. 21st, 1780. The monument is a handsome structure erected by the United States government, and the occasion will be one of wide spread interest to people of the South. Georgia and North Carolina defeated the British, and this conflict is described as the turning point of the war for American freedom. Chester men were in the conflict and Chester citizens will be present on the 7th day of October to participate in the dedication. Arrangements have been provided for transportation to and from the battle ground from Kings Mountain, Grover and Yorkville. The fare from Grover, N. C. to the battle ground and return will only be \$1.00, and it is possible that the larger part of the citizens from here will go, that way.

THE FURNACE CASE.
The official of Jim Farnum in Columbia on Saturday is a serious disappointment to the royal body of citizens of South Carolina. His acquittal is a triumph for debauchery and lawlessness, and adds another link to the disgraceful chain of the old dispensary days. The verdict will meet with the commendation of the good citizens in all parts of the state and will cause South Carolina to become a laughing stock for the other states in the Union.
The Farnum trial is a bitter thing to every citizen and we hope that the next trial of South Carolina will rise in their midst, and put a stop to lawlessness in the name of the state.

A Matter That Needs Attention.
Mr. Editor.—The correspondent for The State in Rock Hill made a paper that 500 bales of cotton sold in Rock Hill on Friday last for 13.15 cents and cotton seed sold the same day for 4 cents.

The correspondent from Chester in The State wrote that paper that Chester's receipts up until Friday was less than that of Rock Hill, and that records show there were sold in Chester on Friday last 123 bales of cotton at less than 12c, with the exception of a few bales that sold for 13c. This he looks bad for Chester's market. The facilities for handling cotton at Chester are equal, if not superior, to Rock Hill's.

Jim Farnum Acquitted.
Columbia, Sept. 25.—The jury in the case of the state against Jas. P. Farnum, charged with bribery, returned a verdict of not guilty this afternoon at four o'clock. The jury was out about five hours.
The state closed its case Thursday and the defense put up no witnesses on Friday. Each side was allowed a half hour for cross-examination, and Mr. F. Stevenson, Mr. B. L. Abney and Attorney General Lyon all spoke for the state. Col. P. H. Nelson, Mr. E. F. Chapman and Mr. A. Haygood addressed the jury in behalf of the defense. Messrs. Samuels and Wylie, the principle witnesses for the state, were severally arraigned by counsel for the defense.

Fire at the White House.
Washington, September 25.—Fire broke out at the white house late this morning and for a short while it was very threatening. It was not in the white house proper, but in the executive offices which are being reconstructed in the King's Mountain. The fire originated in the furnace room. A hot fire had been made in the furnace to dry the plaster freshly put up of the walls. The furnace room was practically gutted and the blaze was communicated to the walls and roof by means of the flue.
The quick response of the firemen resulted in their soon bringing the blaze under control. The damage was slight.
So far as any one here recalls this was the first fire to occur at the white house since the invasion of the national capital by the British in 1814, when the capital was burned and most of the other public buildings were burned.

Mr. Wylie's press publication Mr. Wylie ran to the Columbia papers, and said that he had been misunderstood; that he had talked some, but that he had never drawn the charge of his fellow members of the board with corruption. Dr. J. E. Massey, Mr. F. P. Massey and Dr. J. E. Massey came out in written statements in which they sustained everything in the above paragraph.
Dr. Massey adding further that he had had no interest in the case, and Jim Farnum was still selling beer to the dispensary and giving his rebate.

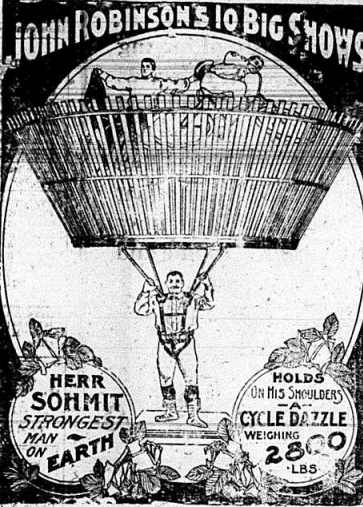
