line, maintaining that all the South should arrange for next season's arsenate requirements. It believes that the Smith method of boll weevil control "promises to have epochal results." The old method of destroying the weevil by poisoning his drinking water, it says, "depended for success, to a large extent, on weather conditions, and calcium arsenate was the only poison that could be used. The Smith method aims at compelling the weevil, at a critical period, to eat the tender leaves at which he is striped of arsenate. The poison is put on these leaves. The weevil, in other words, is killed by what he eats, not by what he drinks. This not only simplifies the method of poison application, decreasing cost, but it also permits, we understand, the use of arsenic in less soluble forms than was possible under the drink-poisoning process.

Few farmers will want to plant unless they can be assured in advance that they can secure arsenic for poisoning. TAX RETURN NOTICE FOR 1923.

In accordance with the law, tax books for the return of real and personal property for the year 1923 will be open on Monday, Jan. 1, and will remain open until February 20, 1923, after which the fifty per cent penalty will be attached to all delinquents.

Sec. J. Art. 283, of the General Assembly of South Carolina, provides as follows: "It shall be the duty of all persons to make returns of all personal property and return all new property that has changed hands real and personal property."

It will be a matter of much accommodation if as many taxpayers as possible will make their returns at the respective appointments mentioned above, so as to avoid the rush at Chester during the closing days.

FORD MOTOR TO THEIF.

Get. Probation for Payroll Padded

Detroit, Dec. 8.—George W. Penmitt, 22 years old, accused of obtaining \$2,500 from the Ford Motor Company by padding payroll, pleaded guilty in Circuit Court today and on recommendation of officials of the company was placed on probation for two years. While \$2,000 was named in the warrant against Penmitt, officials of the Ford company said the total amount missing was approximately \$20,000. Penmitt said he had taken the money to help friends through college.

HUMMING BIRD'S VALUE.

Speaking through its biologists and its ornithologists, the Department of Agriculture says that, contrary to almost universal belief, the humming bird does not live upon the nectar of flowers, though nectar forms an important part of its diet. The birds will hover in front of the cowbird, picking off insects and perhaps the spiders entangled in the web. They will capture food on the wing, after the manner of the flycatcher.

Stomach examination shows that a considerable part of the food of the bird consists of insects, with sometimes a very little of vegetable matter. The rub-throat is the only humming bird which inhabits the eastern part of the United States, and it is found in less numbers everywhere in that region. It eats concentrated sweets, but its favorite animal food is spiders. Gnats or small flies are eaten.

ATTORNEY SEEKS TO REOPEN CASE OF COLUMBIA MAN

Argue That Jeffords, One of Arnette Murder Trio, Did Not Have Fair Trial. Harrison Not Included in State's Case. Attorney Seeks Of Execution Set For Three Days Before Christmas.

Washington, Dec. 8.—With Frank M. Jeffords facing the prospect of death in the electric chair three days before Christmas, E. E. Adkins, Jr., a Washington attorney for the condemned man, expects to visit Chief Justice Taft, of the United States Supreme Court today, and ask that a telegram stating that he has his client's case reopened on the ground that Jeffords did not have a fair and just trial.

Last Monday, Mr. Adams pleaded before Judge Gary in Abbeville for a writ of error whereby the case would have been reopened, but the plea was refused and now the last recourse is the United States Supreme Court today, and ask that a telegram stating that he has his client's case reopened on the ground that Jeffords did not have a fair and just trial.

During the trial of the case, Mr. Adams held, feeling ran so high and the interval between the killing of Arnette and the trial was so short that a public sentiment was arrayed unjustly against Jeffords, the attorney will argue to Chief Justice Taft, that the former President's chamber, that Jeffords did not have the chance for a fair trial promised him by the state and federal constitutions.

In legal parlance, the attorney will ask for a writ of error. This request, Mr. Taft may either grant or refuse today, but the likelihood is that he will take the matter under advisement and give his reply in a day or two. The fact that the attorneys who represented Jeffords at the trial was refused by Judge Townsend when he asked that his clients case be separated from that of the other two men, will be presented to Mr. Taft as a circumstance that militated against Jeffords in the minds of the jury.

World Make Up Mind.

York, Dec. 10.—To have or not to have home and farm demonstration in York county next year, which is the question York solons are grappling with just now. At the next session of the legislature it will be necessary to decide whether appropriation shall be made to carry on the work and in order to determine their course they are desirous of ascertaining the attitude of the taxpayers on the question. With this object in view the York delegation will meet Monday to hear the views of A. McKewen of Rock Hill, district agent of the farm demonstrator who represents the farmers of a continuance of the work in this county next year. Later it is likely that those who oppose an appropriation for this purpose will be given an inlay. Just now sentiment on the question is not very clear, there being many persons on each side.

KLAN WOMEN IN THE PEN.

Seek Incorporation in Indiana. Fines Held Up for Proper Fee.

Indianapolis, Ind., Dec. 7.—Ladies of the Ku Klux Klan of the State of Indiana presented arrested today. Sentence was held up because a check for only \$1 accompanied the incorporation papers. A letter was sent to D. S. Tillman, attorney, of Duncan, Okla., who forwarded the papers, informing him that the fee was \$4.00. The purpose for which this corporation is formed is to educate women in the science of government and history of the United States and to contribute funds to orphanages and religious and similar deserving institutions. The ladies in which are to be done is to limit women in the organization and furnish them a course of study on American ideals, and contributions shall be made by the trustees of the organization or by the local Klansmen.

PENSION ROLL DECLINING.

Cost in Last Fiscal Year Dropped to \$255,201,662.

Washington, Dec. 7.—The American pension system cost the public \$255,201,662 during the fiscal year ended last June 30, according to the annual report of the Commissioner of Pensions sent today to President Harding. Of this amount \$255,867,583 was paid out for pensions, the cost of maintenance of the system being \$1,394,079. That the number of pensions in this country is rapidly diminishing is shown in the statement that \$4,608,259 less was paid in pensions during the last fiscal year than during the previous year; that 25,682 Civil War veterans died, as against 24,776 for the previous year; and that 21,259 widows died, as against 19,453 the year previous. The number of pensioners on the rolls June 30, 1922, was 347,016 compared with 566,053 on June 30 the previous year. Of these, 165,381 were Civil War veterans; 272,194 Civil War widows; 45,965 veterans of the Spanish War and 9,198 widows of Spanish War veterans. There were 73 soldiers drawing pensions for service in the war with Mexico, and 40 widows of soldiers of the War of 1812.

YOUTH DIES FROM WOUND

A peculiarly sad tragedy was that of DePas Brewington, a white boy, aged about 14, who died at the Fryer or hospital in this city from the effects of a gunshot wound in the right leg just below the knee inflicted by Sam Kirkland, a negro. The shooting took place just over the line in Paicfield county, in the Cool Branch Church neighborhood. Kirkland and the boy were alone at the time of the shooting. The negro fled after firing the shot and has made good his escape.

Young Brewington, his brother William and their father, Billy Brewington, were out hunting and from what facts are obtainable DePas Brewington had killed a rabbit, but the game was claimed by the negro, Sam Kirkland. It is alleged that when the boy ran forward to pick up the rabbit, Kirkland's gun fired. The load struck just below the knee, Mr. Brewington and his other son were over the crest of a hill, but ran to the wounded boy's side, and as they came up Kirkland was in the night, his gun in his hand. William Brewington ran to the school house, where an educational rally was in progress, and almost immediately thereafter what had happened, and the wounded boy was placed in an automobile and brought to Fryer hospital, where he died of his blood, however that all efforts to save his life were futile.
