Money with which to erect the woman's dormitory at the University, and to establish schools of journalism and traffic management, to be asked of the legislature, which meets in January, by the trustees of the University, according to decisions reached by the board at the regular December meeting. The board went thoroughly into the University Budget for 1923.

President Melton was instructed to prepare a tentative course of study for the two proposed new schools. The school of traffic management will cover railroad and steamboat rate making and other subjects connected with transportation and commerce. For each school there would be one professor. It is pointed out that there is great need for instruction in journalism, and also that there is a great demand for traffic experts.

There are 125 women students at the University this year, and the dormitory equipment for them is wholly inadequate. It was pointed out at the trustee meeting. The 1923 legislature made a small appropriation for the drawing of plans for the woman's dormitory, and the trustees hope the general assembly will this year provide the funds for the erection of the building.

Reports made by President W. D. Melton to the trustees showed that the enrollment this year is the greatest in the history of the University.

There are already 638 students on the rolls, and President Melton stated that indications are it will reach 750 with the opening of the second after Christmas. Of the total enrollment 197 are law students.

CALCIUM ARSENATE PURCHASED BY BANK

Exchange Bank in Newberry Bay Twenty Tons for Use by Farmers on Neat Crop.

Newberry, Dec. 14.—The Exchange bank has bought a carload, 20 tons, of calcium arsenate and will have it shipped to Newberry and put in warehouses for the use of farmers on next year's cotton crop in fighting the boll weevil. The bank does not intend to make money, for it does not intend to make a cent by it, but it believes the calcium arsenate is going to be scarce and high next year and is getting this much in advance for the use of the farmers. Numbers of farmers in the county have said they would have made much larger crops this year but for the fact that they had run out of calcium arsenate at the last time to use and they would have made much more were not able to get more.

BIG GAME TODAY.

Gaffney High and Thornwell Orphanage Battle in Chester Today for the Upper-South Carolina Championship.

The high school football championship of upper-South Carolina is scheduled to be settled in Chester this afternoon when a game between Gaffney High and Thornwell Orphanage begins at two-thirty o'clock.

The winner of this game is scheduled to meet the Charleston States at University field, in Columbia, next Friday at which time the High school championship of South Carolina is to be settled.

Both of the two teams which play in Chester this afternoon are good teams and an excellent game is expected for the large crowd which is expected to attend. A special train is leaving Gaffney this morning about nine o'clock and is expected to reach Chester about twelve o'clock on which there will be a large crowd of Gaffney fans.

Gaffney team outwings the Thornwell team by possibly 15 points and has a number of outstanding stars, among them being Tommie the head line who is a good ground gainer. In one side of the line will also be found three brothers, the Badger boys, all of whom are good. Many Chester people saw the Gaffney boys play Rock Hill and are in position to vouch for the fact that Gaffney has a good team.

The Thornwell boys, although lighter than the Gaffney boys, are said to be very fast and have wonderful foot work. They have been up against some good teams this year but have managed to come out on top in all of them. It is also said that they keep their opponents on their toes at all times wondering what will happen next.

Competent officials have been secured for the game this afternoon. The referee will be George Bell, who was a star halfback of Carolina last year. Schlichter, who is well known throughout this section, will be the umpire, while Norman, athletic director at Bailey Military Institute, will be the head line man.

While the clouds are very threatening it is hoped that rain will not interfere with the game. Chester has an excellent field and it will take considerable rain to interfere with the players, however. A wet football as a rule, is very easily fumbled and sometimes this is very costly.

The outcome of the game this afternoon will be watched with interest throughout South Carolina.

This Year's Cotton Crop.

The Department of Agriculture in its final estimate of the season faced the production of cotton this year at 9,961,000 bales. The estimate is smaller than any of the four forecasts made this season, which was based on condition of the crop in the various months of the growing season.

Prior to December first the Census Bureau reported that 9,318,144 bales had been ginned. With the exception of last year's crop this year's production will be smaller than any year since 1905. This year's crop in South Carolina is given as 530,000 bales as against 764,500 bales last year.

Texas produced more than one million bales this year over last year.

CIVIC LEAGUE MEETS.

The Civic League had its most enjoyable meeting Monday afternoon, December 11th, with Mrs. T. L. Boardman at Red Bank.

The report of the entertainment committee was heard and further plans were discussed for Joy Night, that this committee is arranging for on Thursday night, December 28th. The chairman of the committee for the Community Christmas Tree exercises reported that plans for these exercises were going forward and suggested that, as the community tree is not yet large enough, to be electrically lighted, a large star, symbolic of the occasion, be constructed that it can be lighted and used this Christmas, and preserved for future use in connection with the Community Christmas Tree exercises. This suggestion was endorsed by the League.

A committee of men from the Chamber of Commerce appeared before the meeting, presented the plans of the community Memorial Building, and asked for a contribution from the League for this building. After a thorough discussion of this matter, it was found to be the sense of the meeting that a contribution be made to the immediate needs of our community, so it was unanimously voted to make a contribution of \$1000, as a memorial from the Civic League to the men from Chester County, who participated in the World War, with the understanding that enough of this fund be reserved by the League to place in this building a tablet to the memory of those men from the county who died in service during the war. A committee was elected from the floor to formulate the terms upon which this contribution will be made, and to present them to the Memorial Building committee.

Mrs. Laitner then asked that the League go on record as being determined to secure such a tablet. The names of all the men from Chester County who were in service during the World War.

At the close of the business session the hostess served refreshments and a delightful social hour was enjoyed.

FORMER POLICE OFFICER OF NORFOLK IS ARRESTED

It Accused of Attempting to Blackmail President of Two National Banks.

Norfolk, Va., Dec. 13.—"I know it looks bad for me, but I did not do it," was the only statement made tonight by Charles W. Brown, former Norfolk policeman, who was arrested here today on charges of using the mails for fraudulent purposes. He is accused of attempting to blackmail W. A. Godwin, president of the Norfolk National bank, and J. B. Moss, president of the Seaboard National bank.

Both Godwin and Moss received letters in which it was demanded that they pay money under threat of death. A letter to Mr. Godwin mailed September 27, asking for \$5,000 and the message to Mr. Moss mailed December 7, demanded \$25,000.

Brown, who was employed as a private detective for several years up until six months ago, has been out of work because business is slack with the agency by which he was employed. Federal agents and Norfolk police detectives, in investigating the case, have worked on the theory that the letters were not written with the intention of obtaining money, but were sent in the hope that the bankers would hire private detectives to investigate the letters, and thus create work for Brown.

TO LANCASTER SUNDAY.
Business Men's Evangelistic Club Goes to Lancaster Sunday by Special Train to Hold Meeting.

PLAN TO INOCULATE ALL DOGS IN SOUTH CAROLINA
Columbia, S. C., Dec. 13—Compulsory inoculation of all dogs in South Carolina as a step toward the eradication of rabies has been approved by the state board of health here, and announcement was made that a bill covering this requirement would be prepared for introduction at the next meeting of the general assembly.

SENATOR LODGE WANTS A CHILD LABOR AMENDMENT
Starts Ball Rolling to Have Such a Proposition Referred to State Legislatures.
Washington, Dec. 13.—Senator Lodge, who represents a large manufacturing constituency, and one that has rivals in the south today started the ball moving for a child labor amendment to the constitution. He introduced a resolution for the senate. The Congress shall have power to prohibit or to regulate the hours of labor in mines, quarries, mills canneries, workshops, factories or manufacturing establishments of any kind under 18 years of age, and of

women." It may take several years to have this amendment ratified, but the present administration is behind it, and will speed it up. President Harding considered the matter in his recent message.
