Scope and Content Note: **The Abortion Interest Movement of South Carolina Records consist of correspondence, speeches, brochures, pamphlets, studies, newspaper clippings, and other records concerning abortion reform not only in South Carolina but in other states. The collection offers a good source of information on the movement to repeal abortion laws not only in South Carolina but also in other parts of the United States and in Europe. The Abortion Interest Movement (AIM) was organized in March, 1969 and developed as an extension of the People for Abortion Reform/Repeal. Its purpose is "to educate the citizens of South Carolina about the need for modern abortion legislation."**

Related Collections: Related collections at this time included the South Carolina Clergy Consultation Service for Problem Pregnancies, (Acc. 66).
