ROCK HILL, S.C. - **Suzanne Anglewicz**, a lobbyist for the National Rifle Association, will talk on Constitution Day on Sept. 16 at Winthrop University about the history of the right to bear arms and recent court opinions relating to the Second Amendment.

Anglewicz is the manager of political and legislative activities for **NRA-ILA's Grassroots Division** where she promotes various NRA programs in support of the right to keep and bear arms. In addition, she coordinates and conducts the association's legislative and election workshops, and represents the association in events and public speaking engagements nationwide.

Before coming to the NRA in 2005, **Anglewicz** worked as a law clerk for one of the most noted Second Amendment attorneys in the country, **Stephen P. Halbrook**, where she gained invaluable legal experience working on various firearm cases before the courts, including the United States Supreme Court. Prior to that, while a law student, she worked for **Michigan Coalition for Responsible Gun Owners** helping citizens promote the safe use and ownership of firearms through legislation and litigation. **Anglewicz** also has extensive political experience working on various state and federal campaigns across her home state of Michigan, as well as previously working for the **Michigan Republican State Committee**.

Anglewicz attended **Michigan State University** earning a bachelor's degree in political theory and constitutional democracy and has also received a Juris Doctor from **Thomas M. Cooley Law School**. She is admitted to both the state of Illinois Bar and Washington, D.C. Bar.
