Scope and Content Note: **The Lineberger Family Papers consist entirely of photocopies of original correspondence, poems, newspaper clippings, photographs, and financial records. The collection also includes photocopies of original American Civil War era records including confederate correspondence, pay rolls, medical records, duty rosters, enlistment records and company rolls related to American Civil War. The bulk of the collection focuses on Company C 28th Regiment North Carolina Volunteers and its captain, Thomas James Lineberger (1838-1928), who was awarded the Southern Cross and is an excellent source for North Carolina History during the Civil War.**

Also included is a genealogy of the Lineberger family with the first entry date being 1777. Of special interest is a signed order issued by General Robert E. Lee dismissing his troops.

Notes: Certain documents of the Lineberger Family Papers were not reproduced for this collection, because they were faded and would not photocopy.
