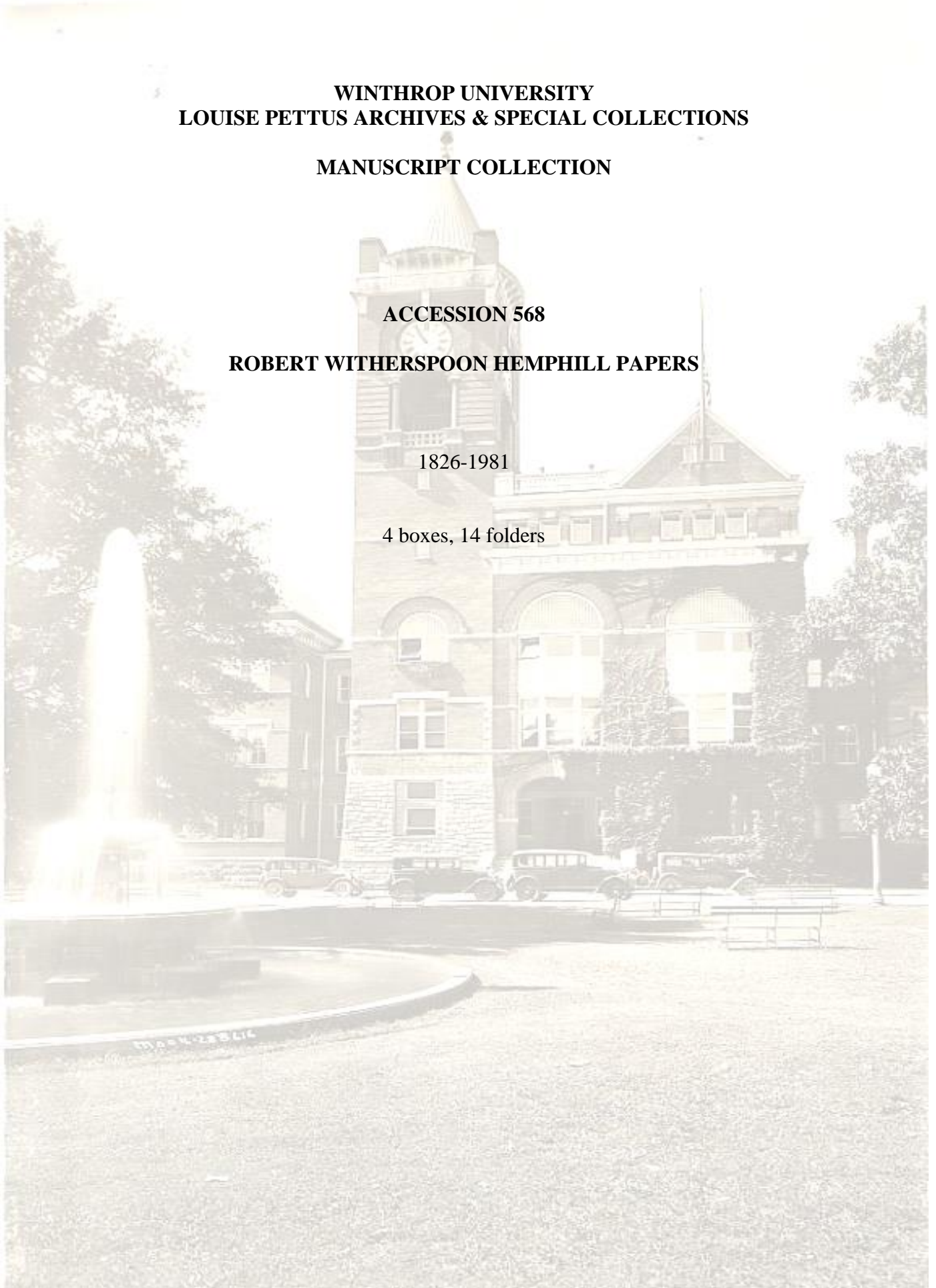

Scope and Content Note: **Robert Witherspoon Hemphill (1915-1983) was a lawyer, judge, civic leader, US Army Air Corp Veteran of World War II, and member of the South Carolina and the United States House of Representatives from Chester, South Carolina. The Robert W. Hemphill Papers includes includes speeches, correspondence, photographs, and newspaper clippings, relating to Hemphill's personal and family affairs. There is also research materials on Aaron Burr, information relating to the Presbyterian Church, and Winnsboro Granite Corporation. Also included are diplomas for Hamilton G. Witherspoon and Robert Witherspoon, financial statements from attorneys concerning wills and the money to be received from them, and there is a letter from the War Department concerning John McClure Hemphill Jr.'s death during World War II and payments to be made to his beneficiary.**
