Scope and Content Note: The Joshua LeLand Abell Family Papers consists of an account ledger for a store owned by E. H Abell (most likely Ephraim Henry Abell (1812-1889)) in Lowrysville, SC (now known as Lowrys, SC) and a photograph album which includes Abell family photographs, most of which are unidentified. The account ledger gives a sampling of everyday life at the turn of the century in Chester County such as costs of various items and services and is also a great source for names of various Chester County residents.

Ephraim Henry Abell was the father of Joshua Leland Abell, Sr. (1876-1897). Joshua Leland Abell, Sr. had several children with one being Charlie Boyd Abell (1885-1975) who had child named Joshua Leland Abell (1914-1969). This son married Winthrop professor Helen Barksdale *Somerville* Abell (1923-2004) on June 4, 1945 (divorced September 25, 1967) who donated the collection in 1984.
